

3.3.4 Texas Senate Bill 212 Reporting Requirement

Fall 2022 Data¹ Board of Trustees TX SB 212 Report²

1. Texas Education code Section 51.253 requires that the institution’s governing board (i.e., Board of Trustees) receives a reporting providing the number of mandatory reports³ of sexual harassment, sexual assault-rape, dating violence⁴ and stalking received.

² Texas Education Code (TEC) Section 51.253 states that, at least once during each fall or spring semester, the chief executive officer shall submit to the institution’s governing body and post on the institution’s Internet website a report governing the reports received under Section 51.252.

³ TEC Section 51.252 states an employee of a postsecondary educational institution who, in the course and scope of employment, witnesses or receives information regarding the occurrence of an incident that the employee reasonably believes constitutes sexual harassment, sexual assault, dating violence, or stalking and is alleged to have been committed by or against a person who was a student enrolled at or an employee of the institution at the time of the incident shall promptly report the incident to the institution’s Title IX Coordinator or deputy Title IX coordinator.

Confidential reports may or may not be reported to OIE. They may or may not be duplicated in the overall reporting numbers.

3. Texas Education Code Section 51.253 also requires that the University report the number of formal investigations involving reports of sexual harassment, sexual assault-rape, dating violence⁷, and stalking which result from mandatory reports by campus employees.

4. Texas Education Code Section 51.253 requires that the University also report the disposition of disciplinary processes resulting from the formal investigation. Incidents of sexual harassment, sexual assault-rape, dating and domestic violence, and stalking which occurred prior to August 14, 2020 are investigated under the prior Policy on Prohibited Discrimination, Harassment and Related Conduct (Policy 1.005-employees; 3.2.16 - students) whereas incidents occurring on or after August 14, 2020 fall under the newly adopted Prohibited Discrimination, Harassment, Sexual Misconduct, and Retaliation Policy⁸ (Policy 1.008).

5. According to TEC Section 51.252, the University must also report the number of sexual harassment, sexual assault-rape, dating violence¹⁰, and stalking reports from mandatory reporters for which the University determined not to initiate a disciplinary process¹¹.
